FRENCH LEGION OF HONOR MEDAL

US Veterans who helped in the liberation of France during WWII could be eligible to receive the French Legion of Honor Medal, previously issued only to WWI Vets. The French Government has asked the Secretary of VA for assistance in identifying qualified US Veterans for medal consideration, to be reviewed and approved by the Legion of Honor Committee in Paris, France. French consulates in the US will distribute approximately 100 medals each year. Members of the Army Air Corps, Navy, and Coast Guard who participated in one of four major campaigns in the liberation of France (Normandy, Southern France, Northern France and the Ardennes) are eligible.

Those applying must have written documentation (normally a copy of military separation order, DD-214, and other official orders which verify military history during combat).

Any previous military awards such as the Congressional Medal of Honor, Silver Star, the Bronze Star, the Purple Heart, etc., would indicate meritorious actions during combat operations.

THE AMERICAN LEGION CHILDREN'S HOME

Did you know that the American Legion had a Children's Home? I had read once that early on in our history the Legion had several Children's homes but that over the years, as society changed, they closed in favor of foster homes. But, during the Fall Conference I found out that, yes, the American Legion has a Children's Home in Ponca City OK.

The home was founded in 1928. The land and funds for the first dormitory were donated by Mr. E. W. Marland, Conoco Oil man and past Governor of Oklahoma. It was established as an orphanage for children of veterans who could not provide care to their young. And the facility presently is the home to 62 children ages 11 – 18. Since its founding, the American Legion Children's Home has served approximately 8,000 children.

The Home is owned by The American Legion and is funded through an Endowment Fund. The principle in the fund cannot be used and the home receives only the interest. As we all know, the economy over the past several years has really been the pits and interest rates are at rock bottom. So the home is in need of other outside assistance and funds.

Even after more than 80 years, they are still growing and increasing their services. Right now they are raising funds for a storm shelter to provide safety during Oklahoma's wonderful weather, an additional dormitory so as to be able to serve more Veteran's children, and a multi-purpose building to house classrooms, conference rooms, chapel, etc.

So, I am asking all of the post in District Three to step up to the plate and assist our Children's Home.

The Department of Missouri has its Spring Conference scheduled for February 19, 2010. I would love to be able to report that our district has a nice check to donate to the Home. If each post could give a minimum of \$50.00 we would have enough to sponsor one child for over a year. They figure a sponsorship is \$800, and \$50 each would be enough for almost two. Or, there are several other options for which to designate our money and that can be decided at our January 10th meeting.

I am suggesting \$50 as a minimum but any amount would be helpful. Maybe your post could hold a fund raiser for this, or take donations from the members of your community.

You can send your checks to me, and make them out to District Three, with a notation as to what it is for. We will then deposit all of the checks and then present one large check to the home.

This is truly the American Legion in Action. Oh yes, and the contribution and efforts in raising the money can also be reported on your Consolidated Post Report under Americanism or Children and Youth.
