We now begin a new membership year. And also, we start a new year for the Legion. As you all know, the district meetings are held four times a year, September, January, April, and June. The location of the meeting rotates around the district.

If you would like to host a district meeting, feel free to contact me so we can schedule your post. The district pays the post for their part. Usually the Ladies' Auxiliary takes care of the meal. All participants bring a cover dish, which eases the burden on our ladies.

The District Ladies Auxiliary hold their meeting at the same time, so there should be room for them to do so.

Now for membership. As I said above, we begin a new membership year. Last year our district ended up being ranked 9th out of 17 districts. This is really not very good. Out of twenty-nine posts only seven posts reached their goal of 100% of the previous year plus one. Several posts were oh so close to attaining their goal, and missed by less than ten members.

But, this is a new year. Let's set a district goal of attaining whatever the membership ended up last year plus one. That means if your post membership last year ended up being 20 members, this year's goal is just one more, or 21

Try signing up active duty personnel. See if your post can afford to pay their dues for a year. Check with the local recruiting office to see if you can get the names of new recruits and write to them while they are in boot camp, then offer them membership when they graduate. Remember, it takes just one day of active duty to be eligible for membership.

It can be done. It may not be easy, but it can be done. Ask yourself, Why do I belong to the Legion? Share your thoughts with these new potential members. You just never know.

THE AMERICAN LEGION

As you all know, in 1919 several officers stationed in Europe with the American Expeditionary Forces came up with the idea of a Veterans Organization who's main goal in life was to serve fellow veterans. Thus, through the hard work of several brilliant men we have The American Legion. Just a little tidbit, The American Legion was chartered by the United States Congress before the Legion ratified its constitution and by-laws and is the oldest federally chartered war time veterans organization in the United States.

Shortly thereafter, in the same year, the Auxiliary was formed to assist the Legion and to also serve veterans. Two years later they held their first convention in Kansas City.

The membership in the Auxiliary is based upon a woman's relation to a veteran, i.e., the mother, wife, daughter, sister, grand-daughter, great-grand-daughter, or grandmother of members of The American Legion, and deceased veterans who served in the United States Armed Forces during the listed war eras. Also, any woman eligible to be a member of The American Legion is also eligible for the Auxiliary and several members are dual members,

Then in 1932 The Sons of The American Legion was created as an organization within The American Legion and is made up of boys and men of all ages whose parents or grandparents served in the United States military and became eligible for membership in The American Legion.

These three organizations all have a national and state organizational structure with constitutions and by-law which govern and guide the officers of their respective organization.

In 1993, American Legion Post 396 of Garded City, Mich. formed a group of bikers and, with the approval of The Department of Michigan and, eventually the National Office. During the National Convention in October of 2007, the members attending the convention approved Resolution No. 35 approving The American Legion Riders as a Program within The American Legion.

This is THE AMERICAN LEGION FAMILY. All of the organizations and programs have one thing in common – THE AMERICAN LEGION. All exist to support the programs of The American Legion. WE ARE LEGIONAIRES FIRST!!!! The reason I say this is because every member MUST have an association with the Legion first.
