On June 25, President Bush signed HR 695 ENR "Army Specialist Joseph P. Micks Federal Flag Code Amendment Act of 2007."

The legislation amended Title 4, United States Code, Chapter 1, Section 7, Subsection 7(m), to authorize the Governor of a State, territory, possession of the United States, or the Mayor of the District of Columbia to order that the National flag
