They are not used as a judgmental tool for or against any post, but the data are compiled and used for such things as explaining to members of congress just how many thousands of hours are volunteered each year by Legion members. They show how the Legion is really accomplishing the support of our goals – the four pillars

Last year, out of 29 posts in our district, only 11 submitted reports. Each of the reporting posts has received a certificate from department. I would love to be able to present a certificate to each and every post in our district. I don't think there is any post that actually can say that they do everything mentioned on the report, but, likewise, I am willing to bet that every post does at least one or two things.

You may think that your post doesn't do anything to record on the report. If you have members who have paid their dues, either annually or PUFL, your post is supporting all of the Legion's programs. The cost of administering Legion programs like the Temporary Financial Assistance, National Emergency Fund, Child Welfare Fund, etc. is only from membership dues. The overhead for these and many other programs administered by the Legion comes, not from the fund, but from dues. I have not heard of any other organization that can claim that.

And that goes for all of the other programs of The American Legion, Legion Baseball, Boys State/Boys Nation, High School Oratorical Competition, Heroes to Hometowns, etc.

So, please fill out your Consolidated Post Report and send them in at the proper time. Let's get 100% reporting. Thank You
