They are not that difficult to fill out and send in and it only takes a few minutes to do so. By submitting your CPR your post gets credit for all of its activities throughout the year, plus the Department and Legion get credit and recognized for what we do. These reports are very important.

Also, each post adjutant should have received by now the annual Post Data Report. Please fill them out and send them in, also. If you have had no change in officers during this year, just state so and return the form to Department.

We were also reminded that it is tax time again and that every post MUST file. Most posts, those making less that \$50,000 should fill out the ecard Form 990. If you miss three years, you WILL lose your tax exempt status and will then be required to pay tax on ALL INCOME, including dues. This is extremely important.

Since La Societe' des Quarante Hommes et Huit Chevaux Grande du Missouri is holding their annual Grande Spring Wreck and Promenade on the weekend of April 10th, 2011, it became necessary for District Three to change the date of our Spring Meeting. The main reason is that most of District Three Officers are also Grand Officers in the Grande du Missouri and are required to be in Festus MO for that weekend. So, we have decided to move the date back to Sunday, April 3rd, 2011. All times remain the same.

For those who are not familiar with it, La Societe' des Quarante Hommes et Huit Chevaux is commonly referred to as the 40 and 8, meaning forty men or eight horses – which was what the normal French Boxcar, during WWI, would hold and was the normal mode of transportation for the troops to an from the front lines.

The 40&8 has a long and wonderful history. It was founded in 1920 by members of The American Legion as a fun and honor society and the founders based the organization on their military experiences in WWI France.

Today it is an independent fraternal organization of wartime veterans, with close ties to the American Legion, whose membership is by invitation only. For more information feel free to contact me or any District Three officer.

Some of us may also lose sight of another very important aspect of The American Legion. We exist to serve, to serve God, Country, Community, and Family. If a veteran is in trouble and needs assistance, we don't ask if he is a member, we help. That is the Legion.
