Since La Societe' des Quarante Hommes et Huit Chevaux Grande du Missouri is holding their annual spring wreck and promenade on the weekend of April 10<sup>th</sup>, 2011, it became necessary for District Three to change the date of our Spring Meeting. The main reason is that most of District Three Officers are also Grand Officers in the Grande du Missouri and are required to be in Festus MO for that weekend. So, we have decided to move the date back to Sunday, April 3<sup>rd</sup>, 2011. All times remain the same.

For those who are not familiar with it, La Societe' des Quarante Hommes et Huit Chevaux is commonly referred to as the 40 and 8, meaning forty men or eight horses – which was what the normal French Boxcar, during WWI, would hold and was the normal mode of transportation for the troops to an from the front lines.

The 40&8 has a long and wonderful history. It was founded in 1920 by members of The American Legion as a fun and honor society and the founders based the organization on their military experiences in WWI France.
